

Northern Indiana Pastel Society 20th Anniversary Exhibit

May 23 – July 12, 2026, Crowley Community Gallery, South Bend Museum of Art

Deliver art Saturday, May 9, 11 a.m. – 2 p.m.

Reception with awards First Friday, June 5, 5–8 p.m. with Around the Bend exhibit

Releasing from exhibit: Monday, July 13, 11a.m. – 2 p.m..

Releasing of art not accepted into the show: Wednesday May 13, Noon–5 p.m.

Jurors: Bill Tourtillotte, art faculty at Indiana Univ. South Bend, and Julie Tourtillotte, art faculty at Saint Mary's College

Each member may enter one or two pastel works. Fee: \$10 for the first entry, \$5 for the second entry. The exhibit will be juried so not all works will be shown. Entry fees will not be refunded if the art is not accepted. Art will not be offered for sale by the museum.

Eligibility: Work must have been completed within three years of the exhibition. The art should not have been shown in a previous NIPS show or at South Bend Museum of Art. There is no size limit. The show is open to NIPS members who are current with their dues for 2026. **Dues of \$25 can be paid by sending a check payable to Northern Indiana Pastel Society in care of treasurer Sue Coultas, 519 Woodruff, Niles, MI, 49120.**

Delivery: Paperwork must be filled out and the tags attached to the artwork before submission. Art must be framed under glass and ready for hanging with wire or D rings. Mats and frames must be in good condition and free of pastel dust. Works must hang for the duration of the exhibit.

Liability: Utmost care will be taken in the handling of paintings. Works in the exhibit will be covered by the museum's insurance. Northern Indiana Pastel Society and South Bend Museum of Art reserve the right to use entries in published material and on their web sites with attribution to the artist.
