Each member may enter two pastel works.

Fee: \$10 for the first entry, \$5 for the second entry. The work listed as Entry Number 1 will be shown. Entry Number 2 may be juried out if space requires. It is likely all works will be shown. There is no size limit. Works must be suitable for a family gallery. Commission on sales is 35 percent to Heartland Art Center.

Eligibility: The art should not have been shown in a previous NIPS show or at Heartland Art Center. The show is open to NIPS members who are current with their dues for 2026. Dues of \$25 can be paid by sending a check payable to Northern Indiana Pastel Society in care of treasurer Sue Coultas, 519 Woodruff, Niles, MI, 49120.

Delivery: Paperwork must be filled out and the tags attached to the artwork before submission. Art must be framed under glass and ready to hang with wire. Mats and frames must be in good condition and free of pastel dust. Works must hang to the end of the show.

Liability: Utmost care will be taken in the handling of paintings. Works in the show should be covered by the artist's insurance. Heartland or NIPS will not accept financial liability for accidents or loss. The Northern Indiana Pastel Society and Heartland Art Center reserve the right to use art images in published material and on their web sites with attribution to the artist.
